- A. Lorraine called meeting to order at 1:15pm
 - 1) Consensus of minutes from February 6, 2022 meeting
 - 2) Lorraine presented a possible LLSC performance on June 16 @ 7pm @ Southpoint for Congressional Medal of Honor Winner, Staff Sgt. David G. Bellavia. We've been asked to sing "The Star Spangled Banner." It was agreed to accept this opportunity as an honor as well as good exposure and an opportunity to hand out cards.  - We will order 500 business cards with an account so we can easily change/add info if needed in the future.
 - 7) Financial Report-Myreta said we currently have \$9,820.48 in our treasury.
 - There are 5 members who are in arears but Myreta will contact them to be paid up in time to be eligible for contest.
 - Frankey said that Charlieanne has officially resigned and won't be returning to chorus. She has taken her off the rolls.
 - Joanne asked about purchasing a plant to give to Marilyn to let her know we still think of her during this time. Because Myreta lives near her she said she will purchase it and deliver it to her.

 - The scores for our performance at contest will be discussed after we get back on Monday, April 11th and a party will be planned for that evening.
 - 4) It was decided at a previous management 'huddle' to look into having a breakfast on day of contest since we have the room to ourselves until we leave to compete.
 - There will be a small fee of \$10.32 for members and guests will pay the full \$42.50 if they want to join us. This will be a surprise for the chorus.
 - 5) A discussion was had about the Covid Guidelines from Region 11 management team concerning testing and masks.
 - There will be a letter coming from the Region to help attendees understand the reasoning behind the decisions made and some ideas on how to alleviate the potent stress to follow the guidelines.
