VI. PR/Marketing – Joanne

a. Promotional Video

- *We have a \$500 credit with Eric to use for a Promotional Video/10 Year Anniversary Camera Roll.
- *Marketing meeting is March 4th at 7:00 pm on Zoom.

Joanne is planning to meet with Eric to discuss a promotional plan.

- *The video will need captions, titles/headings, written commentary, still pictures of quartets in outfits, etc. If we provide the wording, etc., it will cost less approx. \$150, and approx. \$500 if Eric plans out the wording.
- *Carole suggested that since Membership, Marketing, and Events all benefit from the video, the expense should be split between the committees, so no one committee uses their entire yearly budget. (Our current budget does not have line items for all committees)
- *Vicky will handle photographs

- *"Inspiring Donations" set up through Smith's will need to be reregistered by each member sometime in June. Joanne promoted the program at the last BUNCO event.

a. Show Venues

- *Our Patriotic Show is Tuesday, May 20th at Siena. We may add "Go the Distance" and "One Voice". Group Therapy will not be performing. The 3 registered quartets will be
- singing on the show.
 *Siena needs a song list.

b. Ice Cream Social

- *Marilyn is heading the Ice Cream Social held on May 31, 2025.
- *The plan is to sell 200 tickets with the help of Community Lutheran Church.
- *Marilyn is learning about how to use CUR8.com (a way to purchase tickets online).
- *We already have tablecloths and decorations.
- *A donation may be made to Family Promise.

- *We asked Anderson Dairy to donate ice cream for 200 people and are waiting for their answer.
- *Volunteers are needed to ask companies for donations of paper supplies, toppings, etc. to keep cost down.
- *Suggested cost \$10.00 for adults & \$5.00 for children under 12.
- *Flyers will need to be created to post in various locations and on social media.
- *Quartets, Ad Hoc Quartets, and Double Quartets may perform after passing audition in front of the Music Team in the larger practice room. The Chorus may perform, too.
- *No need for risers since groups will perform in various parts of the room (informal setting)

c. Regional Competition Costumes

- *New royal blue tops for competition were ordered, but having enough might be an issue.
- *More details to follow

- *Current Appointed Management Team Members (Anita, Paula, Joanne) must run or may be appointed again.
- *May 8th is our tentative Installation Banquet date.
